

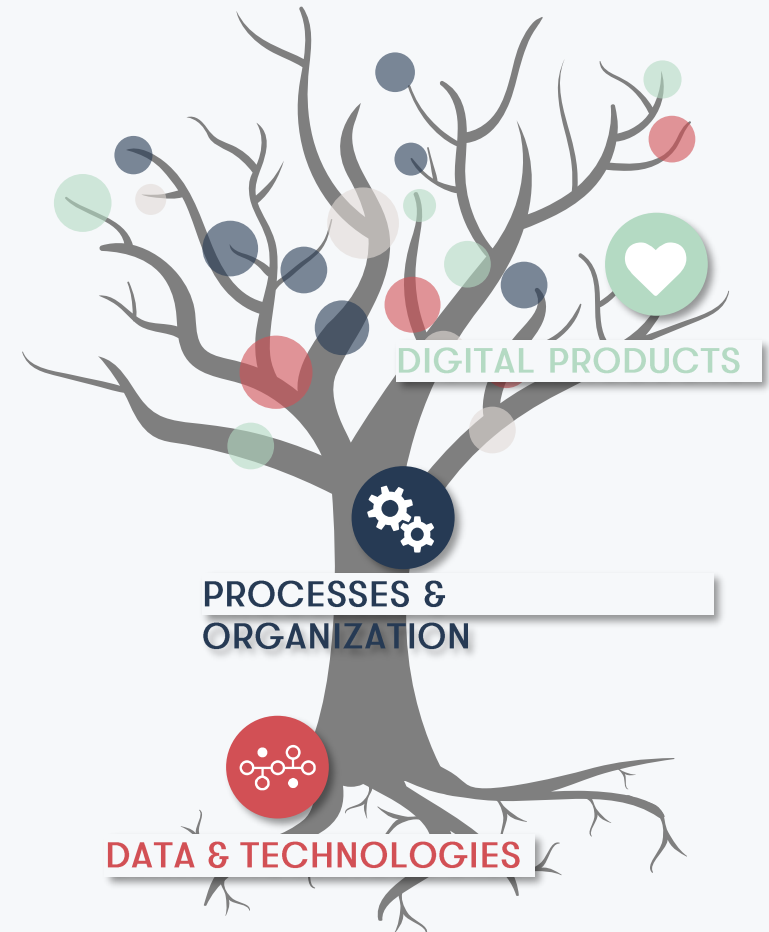

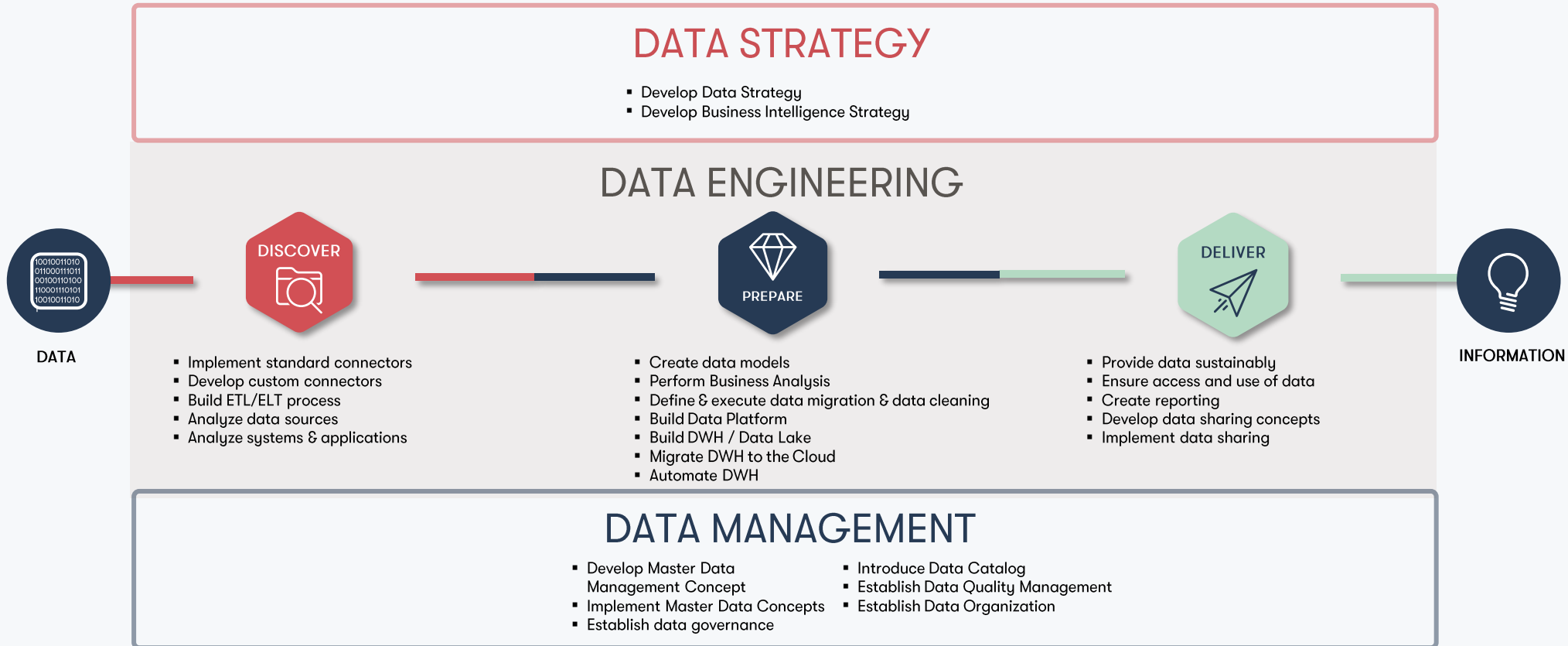

 - Rough assessment of data protection issues in relation to new products and functions
 - Data protection organization: Defined responsibilities and roles incl. tasks
